

**Purpose:** Use this guide to properly completing the PA Exemption Certificate (REV-1220). **NOTE: This** form may be used in conjunction with your sales tax/wholesaler license to claim exemptions from sales tax for the purpose of resale.

**Step 1**: Select the type of tax for which you are claiming an exemption, e.g., to claim a resale exemption for sales tax you would select *State and Local Sales and Use Tax*.

**Step 6**: Provide the completed certificate to the seller. The seller should accept a properly completed exemption certificate in good faith. **NOTE**: **The certificate is not sent to the State.** 

**RETENTION:** 

The seller or lessor must retain this certificate for at least four years from the date of the exempt sale to which the certificate applies.
